



National Trust Membership Types

With the exception of Life Membership, all other membership types are valid for the duration of one year. All new members receive a new member pack.

Household Membership (\$80 + \$33 Joining Fee)

Covers 2 adults and 4 children up to the age of 18. Grandparents can substitute grandchildren for children. The 2 adults can include any family or friendship grouping.

Household Concession Membership (\$56 + \$33 Joining Fee)

As above except at least one adult must be in possession of a Health Care Card, receive a pension or be a full time student. Seniors card holders do not qualify for this membership.

Single Membership (\$56 + \$33 Joining Fee)

Covers one single adult.

Single Concession Membership (\$41 + \$33 Joining Fee)

The purchaser must be in possession of a Health Care Card, receive a pension or be a full-time student. Seniors card holders do not qualify for this membership.

Life Membership (Joint or Household Life Membership: \$1650 or \$1210 for 60+ - Single Life Membership: \$990 or \$770 for 60+)

One payment only for life! Premium dependant on age at time of purchase. Available for Single or Household. Children listed on the household membership cannot inherit or use the membership once they turn 18. Life membership entitles you to the usual benefits of membership and in addition there are special events or invitations for life members including Team of Pianist evenings.

Corporate Membership (\$2000 per subscription)

Includes 10 transferable membership cards to be used by staff for use in Australia only, 10 copies of Trust News per edition, 10% discount on Trust News advertising, invitations for key representatives to attend National Trust special events, certificate of recognition for display, recognition in the Annual Report, on the National Trust website and in Trust News, 10% discount off the use of National Trust properties for functions and use of the National Trust logo on website and promotional material by approval. Valid for one year.

Schools Membership (\$100)

Includes 5 single entry passes for teachers at any one property, 10% discount for students attending National Trust programs in Victoria, 2 copies of Trust News and access to educational resources, learning experiences and safe environments in which to learn.

Institution or Association Membership (\$200 per annum)

Issued with 5 transferable multi-pass tickets, 5 copies of Trust News, recognised in the Annual Report, National Trust (Vic) website and in Trust News, certificate of recognition for display, 10% discount off the use of Victorian National Trust properties for functions and use of the National Trust logo on website and promotional material (by approval). No international visitation rights.

Magazine Subscription (\$32 per annum)

No property visitation or other membership benefit rights. Receipt of quarterly publication *Trust News* only.
